

#### 11.00 Moving towards a physical theory of homeopathy

Alexander Tournier, London, United Kingdom

I will provide an overview of experiments and what they tell us about the physical nature of the homeopathic phenomenon. I will also present experiments from outside the field of homeopathy which provide us with intriguing insights into the phenomenon. I will also present a theory able to explain the observed phenomena, the Quantum Coherence Domains.

#### 11.30 FIONA, le chat «bulle de savon»

A clinical case of a cat with physical and psychic disorders treated with two doses in 200 K of the remedy hydrogenium with follow up of more than 1 year. ### 12.00 Place de l'homéopathie uniciste dans le traitement de la crise suicidaire: évaluation diagnostique et stratégie thérapeutique

William Suerinck. Marseille. France

Exercised with caution, homoeopathy has its place in the treatment of suicidal crisis, alone or in association with conventional treatments. From about ten condensed clinical cases, various strategies of approach are presented, and their limit. An 'integrative' strategy susceptible to take into account, the various trends of thoughts, strengthens the reliability of the prescription.

The child reveals only a part of the primary symptoms; the singular history of their forebears will give these a meaning. ### 09.30 Homeopathy in the treatment of otitis complicated with mastoiditis: 5 case-reports

Françoise Morin, Paris, France

Otitis can evolve with complications; mastoiditis should be suspected when patients show worsened clinical conditions, weight loss or decreased hearing. Homeopathic treatment, used concomitantly and in the follow-up of the classical treatment with antibiotics or allopathy, helped the recovery of auditory loss and good health in the five cases described.

#### 11.00 Psoriasis

Translation provided: English - French

Pierrette Gengoux, Brussels, Belgium

On 9025 cases of dermatologic diseases, 317 patients with psoriasis (3, 5%) where observed in their evolution. 76 (24%) where cured (group a) or in a good evolution (group b) with homeopathy mainly when the remedy was selected by the search of the vital sensation by the method of Raian Sankaran 100% for the group a. 30% for the group b.

### 11.30 Homéopathie et brûlures: mon expérience en service de chirurgie pédiatrique

Isabelle Hofmann, Mundolsheim, France

Twelve years ago the author began to use homeopathy in the treatment of children's burns. She tells the steps of her experience and, after a short reminder of usual evolution of burns, she leans her slideshow on pictures showing the course of burns that had previously not healed so easily.

## 12.00 Effectiveness of homeopathic medicines as add on to institutional management protocol for Acute Encephalitis Syndrome (AES) in children: An observational comparative study

Raj Kumar Manchanda, New Delhi, India

An observational study on 151 children of Acute Encephalitis Syndrome was undertaken at Gorakhpur district, U.P., India, to identify most useful homoeopathic medicines and to evaluate homeopathic treatment (H) as add-on to conventional institutional management protocol in reducing mortality and disability. The most useful homoeopathic medicines have been identified and the results indicate positive outcomes.

### 12.30 Homeopathy with psychotherapy: A new treatment strategy for behavioural problems and ADHD in children

Amit Nimbhorkar, Amravati, India

In today's medical era, behavioural problems supersede other child psychiatric disorders. It's time to look at these problems with a broad spectrum to manage them. Management of ADHD with Homeopathy along with Psychotherapy can become a much acknowledgeable and most applicable line of treatment. This has been elaborated with a case study of 10 years old child.

### 08.30 Transport of anti heat shock effect of Cantharis 200 from one plant to another through water

Anirban Sukul, Kolkata, India

Cowpea batch I, given heat stress connected with batch II (unstressed) and batch III, treated with Cantharis 200c, connected with batch IV (untreated) by capillary water. Batch V: control. FPLC showed similarity in each batch. The change in the water structure by a stimulus, being transmitted through GMN.

#### 09.00 The value of remedy pictures

Edward De Beukelaer, Malborough, United Kingdom

Two case illustrations are used to promote the elaboration of dynamic remedy pictures. One cow benefits from Sarsaparilla for chronic teat cracks. Neon is used to treat a dog based on the remedy picture proposed by the speaker after successfully prescribing this remedy for a cat and having consequently studied the remedy further.

#### 09.30 The skin of Lorenzo

Andreina Fossati, Napoli, Italy

Lorenzo was 14 month old. He suffered from atopic dermatitis. He had been treated with cortisone. I treated him according to Hahnemann's methodology, observing both his illness and behaviour and choosing the suitable medicine for his symptoms. I obtained a visible improvement on both fronts. The follow-up is every month.

#### 10.00 How to prescribe homeopathy in hospital

Simonetta Bernardini, Pitigliano, Italy

In the three years of activity in Pitigliano Hospital we have measured some outcomes to evaluate usefulness of therapies integrated with homeopathy for hospitalized patients adapting the homeopathic protocol to the kind of hospital therapies. The experimentation is in progress and the results will be discussed in the report.

#### 11.00 Role of homeopathy in control and cure of psoriasis

Rajendra Sonawane, Pune, India

After treating 14000+ cases of Psoriasis only with Homeopathic medicines. I have developed a pattern of finding out correct homeopathic medicine from the picture of Psoriasis in a given case. I will be sharing my practical experience and one can apply this in practice. Finding a Similimum in Psoriasis made easy!

### 11.30 How to avoid suppression: The treatment of a case of atopic dermatitis with help of the Hahnemann's theory of psora

Ilya Tiraspolskiy, Moscow, Russia

The purpose of a treatment is to stop pathogenesis of disease and to stimulate its sanogenesis (process of healing). Atopic dermatitis, as a manifestation of the primary psora, is a classical example of sanogenesis, so its' treatment can lead to suppression. How to avoid it is demonstrated with a case.

#### 12.00 Homeopatia texto y arte

Henrique Stiefelmann, São Paulo, Brazil

We work from the text of the patient and comparing with the Thesaurus reaching the medication the patient. We present the case of Sabad, aged 25. Homeopathic Art is a resource diagnostics and evolution in Homeopathy we present 2 cases of Belladonna who repeated the same drawing.

#### 12.30 Homeopathy and physical reality in the light of a new natural philosophy Michael Hartmann, Speyer, Germany

Analyzing the base of science and its relation to mathematics an alternative philosophy of nature is proposed, which is not oriented at a supposedly objective outside world. The physical reality is rather derived from our nature as evolutionary developed beings. Homeopathy must not be regarded as physically grounded.

#### 08.30 El vínculo dinamizado

Sergio Rozenholc, Buenos Aires, Argentina

The relevance of every doctor making deep introspection is that they could transform their own wounds in creative processes to serve others. Dr. Paschero told his students to grow as spiritual people and, raising awareness of true values of existence, they will know the patient subjectivity, where the essential dynamic factors of human pathos live.

### 09.00 Fórmula homeopática de diagnóstico del simillimum: Incurables casos clínicos curados como evidencia homeopática (1° parte)

Carlos Campora, Ciudad de Buenos Aires, Argentina

Three clinical cases traditionally considered "incurable" diseases in a very severe stage were cured following the HFDS' guidelines. We include: a) exhaustive documentation, b) objective tests of clinical outcomes, c) video recordings of consultations. Healing level achieved: Radical Cure according to BRECHA (Argentinean Report and Study Bank of Homeopathic Cases).

## 09.30 Fórmula homeopática de diagnóstico del simillimum: Incurables casos clínicos curados como evidencia homeopática (II° parte) Carlos Campora. Ciudad de Buenos Aires. Argentina

Cases: 1. Rheumathoid Cachexia: patient lost 11 kilograms; cured with Carcinosinum; 2. Multiphasic Disseminated Encephalomyelitis vs. Devic's Neuromyelitis Optica: patient suffered from severe paraparesis, was dependent on a wheelchair; cured with Cinnabaris; 3. Mixed Connective Tissue Disease: patient was over 20 kilograms overweight, suffered from asthma: cured with Natrum carbonicum.

Conclusion: The HFDS is a methodology that applies modern science tools, mathematics and statistics to the scientific research, analysis, thinking, and understanding of clinical cases. By transforming the homeopathic cures from occasional, random and anecdotal into invariable, predictable, reproducible and systematic, the HFDS turns cured cases into true homeopathic evidence.

# 11.00 Efficacy of individualized homeopathic treatment and fluoxetine for moderate to severe depression in peri- and postmenopausal women (HOMDEP-MENOP Study): A randomized, double-dummy, double-blind, placebo-controlled trial

Emma Macías-Cortés, Mexico City, Mexico

Use of homeopathy to treat depression in climacteric is widespread but there is a lack of well-designed studies. A randomized controlled trial was conducted in a public hospital in Mexico. After a six-week treatment, individualized homeopathic treatment and fluoxetine were effective antidepressants in climacteric women. Homeopathy also improves menopausal symptoms.

### 11.30 Combined analysis of homeopathic high quality clinical cases Samuel Arrues. Buenos Aires. Argentina

The conjunct analysis of five fully documented cases with mean 5,4 years of pre-treatment evolution and 3 years of follow up: 1-Fever of unknown origin, 2-Migraine, 3-Recurrent furunculosis, 4-Urticaria, 5-Generalized anxiety disorder, elucidates how High Quality Clinical Case Reports (HHQCRs) can assess the effects of Hahnemannian Homeopathy and may improve the designing of prospective trials.

### 12.00 Una misma enfermedad, diferentes estrategias de abordaje, distintos niveles de curación

Elisabet Susana Aldinger, Buenos Aires, Argentina

Following the methodology of approach strategies developed by Dr Carlos Cámpora I present here three cases of fibromyalgia, a disease on which allopathic treatment has only limited efficacy. The three clinical cases have been approached from different strategies and the level of healing achieved in each has been assessed according to the Brecha Score of Quality for Chronic Cases.

# 12.30 Curaciones clínicas utilizando la fórmula homeopática de diagnostico del simillimun y las estrategias de abordaje de casos clínicos del Dr. Carlos N. A clinical case treated with Loxosceles Laeta for 13 years is presented. The remedy was proved in Argentina in 1998, using the Double Protocol of Homoeopathic Pathogenetic Trial. The most characteristic aspects of the protocol are remarked, together with the evolution of the case, verified symptoms and its healing level.

#### Session on micro-immunotherapy

#### 08.30 Immunomodulation et synergie thérapeutique Lourdes Reig, Consell, Espagne

Immunoregulation is a multifactorial action, requiring to act on different pathways of internal signaling; modulating areas such as Nutrition, Ecology, and the Immune System. The optimal Immunoregulation depends on a therapeutic strategy based on the synergistic actions between different treatments.

#### 08.50 Immunomodulation en cancérologie

Pascal Mensah, Nîmes, France

In case of tumor of solid tissues and to balance the basic cascades of the internal signals implicated in tumor pathologies, the Micro-Immunotherapy with the formula C1, seeks to have an impact on the tumor progression - tumor destruction cycle by supporting the M1 type macrophages development.

### 09.10 The importance of micro-immunotherapy in a holistic homeopathic therepeutic concept regarding lymphatic cancer

Gerhard Hubmann, Vienna, Austria

My therapeutic strategy combines single homeopathic remedies (constitutional therapy, specific approaches that support the organ system) with complex homeopathic remedies (Micro-immunotherapy, homotoxicology) with special focus on patients suffering from lymphatic cancer. After description of Micro-Immunotherapy remedies 2LCL1+2, 2LCLM, 2LKAH, case reports are presented, controlling the progression of the disease by immunomonitoring.

### 09.20 Micro-immunotherapy in cancer therapy with particular consideration of the basic mechanism of cancer development

Gunter Schlegel, Freiburg, Germany

The ten principles of cancer: 1. Increased cell division; 2. Deactivation of apoptosis; 3. Genome instability; 4. Cancer stem cells; 5. Neoangiogenesis; 6. Activated telomerase; 7. Metastasis; 8. Tumormicroenvironment; 9. Anaerobic metabolism; 10. Prooncogenic chronic inflammation. The key role of microimmunotherapy as a complementary homoeopathic and isopathic principle will be mentioned.

09.40 P.A.N.D.AS. syndrome and its probable relation with viral reactivation:
Micro-immunotherapy diagnostic approach - Preliminary results after a 6
months-long treatment on 20 patients

Cesare Santi, Milan, Italy

It has been shown that, in PANDAS syndrome, viral reactivation plays an important part both in diagnosis and in therapy. Clinical data, collected from 20 patients, after 6 months of Microimmunotherapy treatment, demonstrate that the viral hypotheses of PANDAS are plausible and that Microimmunotherapy is an important therapeutic support.

10.00 The development of sequence specific homeopathic DNA remedies for health promotion and disease protection

Peter Kay, Preston, United Kingdom

Homeopathic remedies interact with the genome. The genome contains genes that promote health and others that cause disease. The homeopath Dr. Jenaer perfected the use of potentised DNA molecules to support specific health promoting genes. This has led to development of a series of new gene specific homeopathic DNA remedies.

10.15 Allergie dans l'enfance, signes immunitaires précurseurs d'une maladie systémique - Des résultats thérapeutiques rapides et durables grâce à la micro-immunothérapie

Ursula Bubendorfer, Schwoich, Autriche

Alarming increase of allergy with children. Digestive, nervous, and immune systems, send signals of danger in form of specific symptoms. Unbalance of the immune system leads to microbial infections. Inflammasome activity increases with tendency to autoimmune diseases. Micro-Immunotherapy uses cytokines, chemokines, growth factors, specific nucleic acids in different homeopathic dilutions. Documented clinical cases, fast and lasting results.

#### 11.00 Viral reactivation and micro-immunotherapy: A case report Tiziana Semplici, Milan, Italy

Reactivation of herpes viruses has been shown to influence chronic pathologies. The presentation of clinical cases: medical history and specific laboratory tests – lymphocyte panels and IgG dosage of herpes viruses – before and after microimmunotherapy and/or homotoxicological and neutraceutical medications - shows an improvement in the condition of the patient with both reduction of symptoms and use of allopathic drugs.

### 11.20 Le virus du papillome humain sans ses différentes manifestations: traitement par la miro-immunothérapie

Cristina Zemba-Vieytes, Barcelone, Espagne

Human papillomavirus (HPV) is a DNA virus from the papillomavirus family (Papillomaviridae) capable of infecting humans. There are more than 100 different types, some of them infecting the skin or mucous membranes, where they can produce warts, condyloma acuminata, cervix cancer, penis cancer and oropharyngeal cancer. Micro-Immunotherapy is a safe and effective treatment for these patients.

## 11.40 Micro-immunotherapeutic administration of cytokines ameliorate the clinical symptoms in EAE: An animal model of multiple sclerosis Anna Camps. Barcelona. Spain

Experimental Autoimmune Encephalomyelitis (EAE) was induced in C57BL/6 mice by injecting MOG35-55. Treatment with a cytokine combination, at very low doses (Microimmunotherapy), improves the clinical symptoms in EAE especially during the chronic phase. Moreover, changes in the microglial activation pattern and reduction in the number of infiltrated lymphocytes were observed in treated animals.

#### 12.00 Multiple sclerosis

Renate Schied, Graz, Austria

Multiple sclerosis is an autoimmune disease. The genetic proneness allows antibody development against nerve tissue: myelin and oligodendrocytes. This leads to production of antibodies, which causes destruction of nerve cells, inflammation and attempts of repair. Micro-immunotherapy works with influence on genetic proneness, decrease of antibodies, decrease of inflammation, support of virus defeat.

An experiment on 19 patients with multiple recurrent caries, despite controlled dental and food hygiene demonstrates, after a 4 years hindsight, that we manage to permanently, and almost totally reduce the problem of tooth demineralization and caries phenomenon after a three months treatment of BMP2 and BMP4 protein.

### 12.40 High RANTES in jawbone cavitations: Trigger for systemic disease and surgical and homeopathic solution

Johan Lechner, Munich, Germany

Fatty degenerative osteonecrosis of jawbone (FDOJ) is linked with systemic diseases. We analyzed samples of FDOJ for 7 immune messengers with chemokine RANTES at high levels. 23 breast cancer (MaCa) patients showed overexpressed RANTES in jawbone, thus RANTES in FDOJ contributes to propensity towards MaCa. Surgery of FDOJ needs complementary therapy with high potencies of RANTES.

Main issues of Am-c. will be developed, according to the analysis of Marc Brunson and the CLH, based on the tripod raw material - materia medica - clinical cases.

This presentation summarizes homeopathic treatments with snake remedies of cats suffering from Eosinophilic granuloma complex. Upon examining the true nature of infectious disease from a holistic perspective we can effectively analyze Public Health Care models of infectious disease prevention. We will compare and contrast through clinical outcomes vaccination with Genus Epidemicus and Homeoprophylaxis (HP) to determine which model is more suitable to fulfill the role infectious disease plays in the evolution of the individual and collectively.

#### 09.00 Identification of unknown homeopathic remedies by delayed luminescence Karin Lenger, Offenbach, Germany

Photons are detected by magnetic resonance in homeopathic remedies. The potencies' levels are measured by two methods 1) by their characteristic resonating magnetic field or 2) by their number of photons emitted, both increasing from low to high potencies. Through these methods it is possible to distinguish between remedies and placebos because of their different resonance frequencies and spectra.

The presence of animals in our lives affects us in ways that may be invisible to us. These invisible links may become visible through the process of homeopathic diagnosis and treatment. The 'animan' (animal and man) concept can be illustrated through treated and cured animal homeopathic cases.

### 11.30 The homeopathic unicist technique in unconventional animals: Three clinical cases

Gustavo Picci, Cortona, Italy

The author describes the treatment of Metabolic Bone Disease in some iguanas living with mandibular deviation, maxillary abscess and deviation of the spinal column. Furthermore, the treatment of a neurological syndrome in a Border Canary affected by Staphyl. Aureus meningitis, and the treatment of the syndrome «Going Light» in a parrot Lovebird are analysed.

Based on a few veterinary clinical cases the author reflects on Kent's 6th and 7th Prognostic Observations as put forward by Alfonso Masi-Elizalde. A dog with mediastinal neoplasm, another dog with thyroid cancer and a third dog with massive renal degeneration and severe renal failure. In all these cases, the administration of the individualized remedy has reversed the prognosis, rapidly leading to unexpected outcomes.

#### 14.30 A case of planum sphenoidal meningioma with aortic stenosis Pravin Beedkar, Aurangabad, India

A 63 yrs old female patient consults to control the growth of tumor. It was operated eight month back. Again it starts growing fast. Patient diagnosed Planum Sphenoidale Meningioma after presenting with vision loss in left eye and Aortic Stenosis. Homoeopathic medicine not only reduced the tumor but also helps to normalize the aortic valve.

Introduction of patient with diagnostic reports—USG SCAN, and hospital discharge reports; Briefing carcinoma stomach; Symptoms of the patient, analysis of the symptoms, totality; Arriving to similimmum, selection of medicine, differentiating with close running medicines; Observation after medicine; Scanning reports after medication, video footage of patient; Testimony by patient

## 17.30 Comparison of healing levels achieved in cancer patients by using the conventional palliative therapy and individualized homeopathic treatment Francesca Talarico, City of Catanzaro, Italy

We treated seven cancer patients with the conventional palliative therapy, seven with individualized homeopathic treatment (IHT). We assessed their quality of life in basal conditions, after one and four months of treatment. The statistical analysis was performed. IHT gave a global healing, with significant clinical improvements compared to the control.

#### 18.00 Homeopathic supportive and palliative approach for cancer patients Mikako Harada, Kagoshima, Japan

During the cancer treatment, there are essential needs which homeopathy play a complimentary role. We prescribe homeopathy based on the repertorisation with or without combination of organ specific, symptom specific, cancer nosode, cancer and constitutional remedies. Patients were relieved from anxiety, could sleep better and got along well with the family members.

### 14.00 Role of homeopathy in management of respiratory tract allergies Geeta Arora. New Delhi. India

Respiratory tract allergies are on a rise throughout the world. The cases presented here show role of homeopathy in tackling respiratory allergies and show very good results for treatment based on constitutional line of treatment.

#### 14.30 A special case

Gio Meijer, Amsterdam, The Netherlands

A case of leukemia treated with homeopathy. There was a relation between her complaints, and a Legionella infection three years before the cancer started. She was treated with isopathy because of the etiology, later she got her similium, fitting the cancer miasm and was cured without conventional treatment.

### 15.00 Homeopathy and immunology in infectious diseases: Evidence based medicine

Sudhir Batra. Delhi. India

Immune modulation with the use of Homoeopathy can be demonstrated by monitoring the levels of bio-markers like cytokines, Interleukins, etc. Another way is to show the gene or gene expression modulation with Homoeopathy. The future strategy should be aimed to show the laboratory evidence demonstrating these levels- pre and post treatment.

In collaboration with the Laboratory of Saint Antoine's Hospital, in Paris, I wanted to prove the activity of high dilutions by moving the QNB\* (Quinuclidiny bensilate) with dilutions higher than 10-<sup>22</sup> of Atropin sulphate and Belladonna in the muscarinic spots or receptors (radioactive technic and electronic microscopy). When we have rats who drink every day Belladonna 4CH, they are more sensible to homeopathic dilutions than the others.

Plant materials are used in a big proportion to make medicines in homeopathy. #### 14.30 Cas clinique de mobilité dentaire inquiétante avec hypersensibilité au froid Christine Roess, Colmar, France

Clinical case of a patient presenting a very worrying dental mobility with committed vital prognosis, straight after having been laid an inlay. The etiology was neither traumatic nor occlusal, so a homeopathic treatment of the patient's terrain solved the case in a few days. This clearly shows the importance of considering the global aspect of a case in homeopathic treatment.

An initial remedy X gives no result, and the nightmare repeats itself. By taking into account a psychological factor, a remedy Y makes the physical symptoms, as well as the nightmares, disappear.

#### 16.30 Bohn nodules in a newborn: Differential diagnosis and homeopathic treatment Marie Elena Monterde, Mexico City, Mexico

In order to understand the patient and the remedy (Thulium oxydatum), many stages with the use of different tools have been necessary: repertorisation, periodic table, and Materia Medica for confirmation.

#### 08.30 Extending the homeopathic paradigm

Anton Popov, Kiev, Ukraine

The homeopathic paradigm is not confined to "healing" in the accepted meaning, but extends to a positive way of thinking and seeing the world. Homeopathy gives an opportunity to identify oneself and be true to oneself. The symptoms of pathogeneses can serve for discovery human capacities and determining one's predestination.

### 09.00 The use of homeopathy in obstetrics in Switzerland Martin Frei-Erb, Klaus von Ammon, Bern, Switzerland

This follow-up study was to detect changes in the use of homeopathy in obstetrics since 1999 and to expand the survey to all regions of Switzerland. Homeopathy is still widely used in the German speaking part of Switzerland, while it is modestly employed in the French and Italian regions.

# 09.30 Impact of China rubra 7C on the side effects of quinine: A prospective, randomised study comparing China rubra 7C plus quinine vs. quinine only in pregnant women with malaria in Cotonou, Benin Frédéric Rérolle, Lyon, France

105 women received quinine plus China rubra 7CH (China group) and 106 received quinine only (Standard group). In China group, a decrease in proportion of patients presenting with side-effects was observed from day 0 to day 6 of follow-up whereas the proportion of patients in Standard group with side-effects did not change significantly during this time.

### 10.00 Ma vie est comme un entonnoir Marie-France Etre, Aubergenville, France

Once upon a time there was a 50 yr old woman whose life 'got in a funnel', with a sense of fragmentation of the body, a desire to commit suicide, loss of energy. The magic fairy of homeopathy passed by, the woman not only survived all her troubles, she also found more meaning to life through creation.

### 11.00 An evidence based study on cases of polycystic ovarian disease in response to homeopathic medicines

Girish Gupta, Lucknow, India

An evidence based study was conducted on 180 patients to develop standardized and quality controlled data on the effect of Homoeopathic drugs in PCOD. Vulnerable age group was 21-35 years (126-70.00%). Positive response was obtained in 129(71.67%) with complete resolution in 97(53.89%) and improvement in 32(17.78%).

#### 11.30 Place of homeopathy in endocrine diseases

Didier Deswarte. La Madeleine lez Lille. France

Endocrinology, systemic discipline and joined the global model of the homeopathic similarity in its foundations and its mode of action. We discuss clinical applications but also practical implications of this new concept of endocrine disruptors which calls into question the very concept of dose toxicology effect.

#### 12.00 Disease, biologic conflict and simillimum

Giovanni Alvino, Mercato S. Severino, Italy

#### 08.30 Treating a post corrosive oesophageal stricture with homeopathy Piyush Joshy, Vadodara, India

A case of accidental etiology, of post corrosive esophageal stricture, can be treated with superior efficacy taking advantage of homoeopathic methodology of individualization, dynamic remedy and totality of symptoms, consequently achieving the highest ideal of cure, 'rapid, gentle, permanent', as laid down in Organon of Medicine by Dr. Samuel Hahnemann

#### 09.00 How to treat patients with psychiatric disorders Seyedaghanoor Sadeghi, Tehran, Iran

While more than 33% of people world over are suffering from psychiatric signs and symptoms, according to the World Health Organisation, homeopathic remedies may provide a rapid, gentle and permanent method of healing. About 1000 patients were treated effectively with classical homeopathy during 5.5 years. Randomized clinical trials are suggested.

### 09.30 Homeopathy on the move: Strategies in Indian rural set up Mihir Parikh, Vadodara, India

Achieving 'Health for all' by Reaching to the Unreached section of the society is the objective. Implementing strategies – emphasizing need of Multi disciplinary and Multi centric approach was taken up by creating a Team. Various epidemics were treated Homoeopathically. Homoeopathy with Preventive, Promotive and Curative aspects is given priority.

#### 10.00 Homeopathy for patients with schizophrenia Ronko Itamura, Tokyo, Japan

Schizophrenia is a chronic and recurring disease. I will present three cases with schizophrenia and indications of recovery from schizophrenia through homeopathy are defined as three steps. Homeopathy can be very useful in addition to or instead of medication for schizophrenia, including the use of a three-step strategy.

A study of 100 cases (63 breast lumps and 37 ovarian cysts) was undertaken to study the efficacy of homoeopathic medicines in these cases. Before and after ulatrasonogaraphy was done in all the cases to provide scientific evidence of the study. We will discuss the results.

### 11.30 A case study of chronic chorea in an old man cured by homeopathy Sheo Murti Singh, Allahabad, India

'Chorea' is a neurological disorder characterized by abnormal, repetitive, uncoordinated involuntary movements. The Evidence based (Audio-visual) well documented case of a 65 years, male, presenting with complaints of chronic facial 'chorea', involving nearly all voluntary and involuntary muscles not responded by other disciplines, but cured by Homoeopathy completely.

### 12.00 A case of Guillain Barré Syndrome cured with homeopathy A.K. Gupta, New Delhi, India

Guillain-Barré syndrome is an acute illness caused by inflammation of peripheral nerves leading to loss of sensation, muscle weakness and, in more serious cases, complete paralysis and breathing difficulty. 80% of cases have preceding a recent illness (usually viral). Case of Ayesha suffering from GB Syndrome got cured with Homoeopathy. Homoeopathy plays an important role in treatment such cases.

### 12.30 Clinical efficacy in chorionic hematoma Karen Allen, Phoenix, United States

Chorionic hematoma is the most common sonographic abnormality detected in viable pregnancy. Homeopathy offers strong options for prompt resolution. Karen Allen, CCH presents a retrospective case study of 18 women with hematoma, showing efficacy and raising interesting questions about potency selection in physical pathology based on the results.

And, the perplexity of terminology haunts the homoeopathic physicians across the globe even in the 21st century. Unless thoroughly investigated, this shall persist to be a sore point or the 'itch' of homoeopathy.

### 09.00 Superbug crisis proves vital dynamics Saniav Gupta. Bhopal. India

Man has worsened his own suffering by introducing illogical / time bound solutions to dynamic issues. Superbug is an offspring of his negligence and overuse of available resources. Homoeopathy the science of vital dynamics of life alarms this butchery and also guides the way to a healthier happier simpler life.

### 09.30 Building remedy profiles form clinical observation: A short case series of two 'minor' nosodes

Russell Malcolm, Luton, United Kingdom

Patients often present with 'Gateway Indications' for a nosode. However, many valuable nosodes are frankly 'un-repertorisable' using standard repertories. Specialist repertory data sets derived from case series' are under development. The outline remedy pictures for two lesser known bowel nosodes will be presented, based on case-data rationally extracted and collated.

### 10.00 Modern view of homeopathy based on an imbalance of miasms described by Samuel Hahnemann

Kateryna Tsvyetkova, Kiev, Ukraine

New approach to homeopathic prescription, based on Hahnemann's theory of miasms is presented. Different balances between the main miasms of Hahnemann in seven main age groups can control health, while an imbalance leads to different diseases. ## 11.00 A clinical study of the influence of homeopathic remedies over autonomic nervous system by measuring of heart rate variability in a group of 50 patients

50 patients have been tested for tonus of the ANS by measurement of heart rate variability (HRV) before and after the administration of homeopathic remedy. HRV increases after homeopathic remedy in most of the cases that indicates the organism is in better condition. Measurements prove the immediate effect of the remedies over the physiological state of the organism.

## 11.30 The role of Italian avant-garde in the diffusion and application of Hahnemann's medicine in 1800, new acquisitions on communication Michela Ridolfi & Gaetano-Maria Miccichè, Rome, Italy

Eminent Italian personalities had already understood by the end of the 1700's, the genius of Hahnemann at the beginning of his scientific speculation, observing and following the foundations of homeopathic medicine. Postilions, carriages, and a "pure syntony of body and mind" as well as spreading the new medicine news in Italy.

## 12.00 The concept form: A criterion justifying the art of homeopathic healing – Life force: Game and counter game of the form between visible signs and invisible symptoms

The miasm made flesh as an invisible symptom, that is impossibile to see (203, 279 C.D.) Homeopathic healing art is a divided opera determined by the difference between visible disease and invisible miasm. Intimate outward appearance or inner foreign territory: source, certainty and form of Hahnemannian truth (60, 69 Organon).

### 12.30 Secrets of evolution of miasms and homoeopathy Ramabhai A. Patel, New Delhi, India

When philosophy of TRIDOSAJ of Indian system of medicine (Ayurveda) was compared with TRIMIASMATIC philosophy of Homoeopathy it was astonishingly found that characteristic stigmas depicted in each philosophy of each one went parallel with its counterpart, and writing of contemporaries generated more interest finally to establish that Homoeopathic science is miniature copy of Ayurveda.

We will discuss the case of a patient with neurodermatitis for more than 11 years: treatment and follow-up. The use of high LM potencies, in cases with many mental symptoms, speeds up the healing process and decreases the risk of aggravations.

Cuscuta Europea, is a climbing parasitical plant. Four working groups have proved it using the classical or the trituration methodology. The homeopathic pathogenetic trial (HPT) is discussed in terms of its importance within homoeopathy and its deviations from the methodological and ethical norms of early phase trials. The LMHI, ECH and HPCUS guidelines for HPTs are compared and the ethical considerations are evaluated.

## 11.30 A comparison of the homeopathic drug proving of the venom of the Eastern Green Mamba (dendroaspis angusticeps) to the proving symptoms of Black Mamba (dendroaspis polylepis) venom

Madhueshwaree Maharaj, Durban, South Africa

South Africa has a vast range of indigenous species of fauna and flora, some of which are used traditionally for healing. The findings of a double-blind, placebo controlled homoeopathic proving of Dendroaspis angusticeps 30CH will be presented, with a subsequent comparison of the derived symptoms of Dendroaspis angusticeps with the published symptoms of Dendroaspis polylepis.

### 12.00 A homeopathic approach to treat middle-aged Japanese women with Lachesis muta: Two case reports

Mari Doi, Hirakata, Japan

Two Japanese women with anxiety were cured with Lachesis muta. Their underlying problems were the suppressed desire for attracting attention and the strong sexual drive. It took time to reveal them because they were culturally inadequate theme for women. It is important to consider the cultural influence and patient's psychodynamics.

#### 12.30 Development and refinement of the proving

Gustavo Dominici, Rome, Italy

The Author has refined the original Hahnemannian methodology by making significant modifications. The proving of Streptococcinum, tested at the School of Homeopathy in Verona in 2012, is shown. The symptoms produced were intense and characteristic. Finally it shows a clinical case of serious post-urethritic reactive arthritis cured by Streptococcinum.

### 15.00 When another methodology overcomes the shortcomings of the medical medica

I used the same method for 3 cases, namely the understanding of the theme of the remedy. Very 'classic' in the way I usually work, I stayed without solution on the basis of a répertorisation. It is obvious that we can find in the repertory only the explored part of a remedy. The confrontation of the cured clinical symptoms and the remedy origin allows to assert that the symptoms of these 3 patients would have been present in the repertory if the remedy had been enough studied.

Treated with Arsenicum album in LM potencies after two year was removed from the transplantation list and has improved the quality of is life.

### 14.00 Paralytic ileus after ileocystoplasty in a patient with spinal cord injury Susanne Pannek-Rademacher, Zug, Switzerland

A paralytic ileus is a typical complication of ileocystoplasty of the bladder. In patients with a spinal cord injury, this risk is higher due to a preexisting neurogenic bowel dysfunction. We present the case of a paraplegic man who developed a massive paralytic ileus after ileocystoplasty and surgical revision.

### 14.30 The museum of homeopathy: Italian historical archive Francesco Eugenio Negro. Rome. Italy

The Museum of Homeopathy – the Italian Historical Archive was inaugurated in Rome in 2013. It contains 80,000 books, over 100 kits of remedies, about 3,000 "memorabilia" (letters, manuscripts, autographs, medals,etc.) and a complete collection of worldwide postage stamps commemorating Homeopathy. This prestigious center, which overlooks the historical Navona Square, is where Antonio Negro reorganized Italian Homeopathy in the 1940's.

## 15.00 Homeopathic treatment of patients attending a rural primary health care clinic in the Valley of a Thousand Hills, KwaZulu Natal, South Africa Cornélia Hall. Durban. South Africa

The author will present an overview of different homoeopathic approaches in the adjunctive management of various pathologies in an impoverished rural community based setting. Cases will demonstrate the impact of homoeopathy both as palliative and curative modality. Conditions such as HIV/AIDS, Tuberculosis, skin diseases and psychological disorders will be discussed.

### 15.30 Homeopathic management in depressive episodes: A prospective, unicentric, non-comparative, open label observational study Praveen Oberai, Delhi, India

An observational study on 85 patients was undertaken at Central Research Institute (H), Kottayam, India, to evaluate the role of homoeopathic medicines in management of depressive episodes. Statistically significant differences were observed in HDRS, BDI and CGI scales after six months. Further controlled studies are needed to assess the efficacy.

### 14.00 Evaluation of Lappa arctium and Zingiber officinale in treatment of acne vulgaris

Anjali Miglani, New Delhi, India

The paper discusses about two separate exploratory, non-randomized studies with Lappa Arctium (ClinicalTrials.gov Identifier: NCT01040390) and Zingiber Officinale (ClinicalTrials.gov Identifier: NCT01321632). The results include change in acne lesion counts, reduction in Global Acne Grading System (GAGS) score and improvement in Acne-Specific Quality of Life questionnaire (Acne-QoL) score during the six months follow up of each subject.

### 14.30 A clinical study on continuation of action of fiftymillesimal potency after suspending its administration

Indrani Chakrabarti, Kolkata, India

Two cases were treated with fiftymillesimal potency and though the common practice is to repeat a dose every day or every alternate day in chronic disease but it was observed that a dose of fifty millesimal potency continued to improve a case of vitiligo and give relief to pain in a case of secondary spinal canal stenosis for more than a month after suspending the administration of the remedy during its course of treatment.

### 15.00 Role of homoeopathic medicines in prenatal and antenatal care Sapna Gupta, Gwalior, India

Homeopathy is of immense importance in helping the female to cope with the changes in her body without affecting the growing child. Pregnancy is considered the ideal time for prescribing medicines which could help in establishing the health of both mother and her growing child. Well-chosen homeopathic remedies will help cure all complaints and are safe and have no side effects.

### 15.30 Homeopathic management of urolithiasis in reproductive age group females: An evidence based study

In finding any cure the most important things to know are what is health and what is disease. Every person has different diseases during his life, so in order to see if the applied treatment cures or just affects some symptoms, we need to define and find his levels of disease.

### 17.00 Evidence based study: Efficacy of homeopathic drugs in cases of kidney stones

Ritu Raj Agarwala, Burdwan, India

Homoeopathic medicine offers the most cost effective and less suffering treatment for the passage of kidney stone. It also prevents from the recurrence of stones even after surgical treatments. Berb. V, Lycopodium clavatum, Sarsapirilla, Sulphur, etc. are effective medicines at high dilution for kidney stone including secondary infection to urinary tract.

#### 17.30 My experience with end stage renal disease: Limitation of homeopathy Pankaj Aggarwal, Delhi, India

A study where-in 46 patients (with/without Dialysis) of ESRD were treated with similimum. Here-in, I learnt the importance of BIO-PSYCO-SOCIAL factors in Prescribing Similimum. A remarkable relief of 54.3% with significant p-value proved the effectiveness of Similimum. But, level-2 of Healing could be achieved.

### 18.00 Homeopathy in urban primary healthcare units of the Delhi government: An assessment

Surender Verma, Delhi, India

Delhi, though becoming a hub of medical tourism, is finding it hard to provide a reasonably cost-effective primary and secondary healthcare system for its habitants. Homeopathy can be an answer by providing economical treatment. This paper explores popularity and cost-effectiveness of Delhi government homoeopathic units and also analyses the utility of their services by public.

A comparison between the first indications of Carcinosinum, layed down by Foubister and the results of the Escuela de México proving. The Carcinosinum indications were first summarized and organized. A full mental investigation was done, to understand who is the Carcinosinum patient, followed by a physiologic clinical analysis.

#### 14.30 Proving of Culex Musca

Sergio Segantini, Firenze, Italy

The Proving of Culex Musca is based on a double-blind placebo controlled trial. The research is the result of the collaboration between two Italian Schools of Classic Homeopathy and involved 51 provers. More than 300 symptoms have been collected and registered in conformity with the homeopathic repertory Synthesis. The study has been carried out according to ECH auidelines.

#### 15.00 Reporting of homeopathic pathogenetic trails: Main recommendations from a first analysis

Jean Pierre Jansen. Groningen. The Netherlands

This study compares differences in methodological quality of provings conducted between 1945-1995 versus 2008-2011, using Dantas' 'Main Quality Index'. Missing data may affect the results of this comparison. Since 1995 no important improvement is apparent. We recommend developing guidelines for reporting provings, and further investigation of the supervision process.

#### 15.30 Proving of Hekla Lava

Nicolienne Potgieter Steiner, Zug, Switzerland

Hekla Lava is prescribed based on observations of clinical symptoms caused in grazing animals. The proving of Hekla Lava not only confirmed well-known effects on bones and teeth but contributed many new symptoms, indicating it as useful in the elderly and in treatment of arteriosclerosis or Alzheimer's. This proving presents new and interesting therapeutic possibilities.




